# I Executive Summary

Memorial Hospital Flagler, Inc. d/b/a AdventHealth Palm Coast will be referred to in this document as AdventHealth Palm Coast or the “Hospital”.

## Community Health Needs Assessment Process

AdventHealth Palm Coast in Palm Coast, Florida, conducted a community health needs assessment in 2022. The assessment identified the health-related needs of the community including low-income, minority and other underserved populations. This assessment process was the most comprehensive to date and included survey questions related to diversity, equity and inclusion. In addition, the priorities were defined, when possible, in alignment with Healthy People 2030, national public health priorities to improve health and well-being.

In order to ensure broad community input, AdventHealth Palm Coast created a Community Health Needs Assessment Committee (CHNAC) to help guide the Hospital through the assessment process. The CHNAC included representation from the Hospital, public health experts and the broad community. This included intentional representation from low-income, minority and other underserved populations. The prioritization process sought to balance our ability to impact the greatest number of people who are facing the greatest disparities.

AdventHealth Palm Coast also convened a Hospital Health Needs Assessment Committee (HHNAC) to help select the needs the Hospital could most effectively address to support the community. The HHNAC made decisions by reviewing the priorities selected by the CHNAC and the internal Hospital resources available.

The CHNAC and HHNAC met throughout 2021-2022. The members reviewed the primary and secondary data, helped define the priorities to be addressed and helped develop the Community Health Plan to address those priorities. Learn more about Healthy People 2030 at <https://health.gov/healthypeople>.

## Community Health Plan Process

The Community Health Plan (CHP), or implementation strategy, is the Hospital’s action plan to address the priorities identified from the CHNA. The plan was developed by the CHNAC, HHNAC and input received from stakeholders across sectors including public health, faith-based, business and individuals directly impacted.

The CHP outlines targeted interventions and measurable outcomes for each priority noted below. It includes resources the Hospital will commit and notes any planned collaborations between the Hospital and other community organizations and hospitals.

The identified goals and objectives were carefully crafted, considering evidence-based interventions and AdventHealth’s Diversity, Equity, and Inclusion and Faith Accountability strategies. AdventHealth Palm Coast is committed to addressing the needs of the community, especially the most vulnerable populations, to bring wholeness to all we serve.

## Board Approval

On March 28, 2023, the AdventHealth Palm Coast Board approved the Community Health Plan goals, objectives and next steps. A link to the 2023 Community Health Plan was posted on the Hospital's website prior to May 15, 2023.

## Ongoing Evaluation

AdventHealth Palm Coast's fiscal year is January – December. For 2023, the Community Health Plan will be deployed beginning May 15, 2023, and evaluated at the end of the calendar year. In 2024 and beyond, the CHP will be evaluated annually for the 12-month period beginning January 1st and ending December 31st. Evaluation results will be attached to the Hospital's IRS Form 990, Schedule H. The collective monitoring and reporting will ensure the plan remains relevant and effective.

# Behavioral Health: Drug and Substance Use

Fentanyl deaths in Flagler County increased nearly eightfold from 2013 to 2019 and opioid-related deaths doubled from 2019 to 2020 despite decreasing statewide. Awareness of and the need to address substance misuse, as well as a growing fentanyl crisis, has been increasing in the country. By addressing alcohol and drug misuse as a priority, the Hospital can align to local, state and national efforts for resources to create better outcomes opportunities over the next three years.

**Goal 1:** Increase the rate of persons with an opioid use disorder receiving medications for addiction treatment in partnership with Flagler Cares/Coordinated Opioid Recovery (CORE) Program. This coordinated approach to treat opioid use disorder and prevent overdose includes education, awareness, outreach, intervention, and treatment. *(Healthy People 2030)*

**Objective 1.1:** Hold 16 Narcan Education & Distribution Events with Flagler Open Arms Recovery Services (OARS) at the Hospital and with local community and faith partners by December 31, 2025. *(Faith Community Strategy)*

**Objective 1.2:** By December 31, 2025, increase the proportion persons suffering from substance use disorder who are connected to sustainable care through Flagler Cares. Increase awareness of Opioid Use Disorder/Substance Use Disorder (OUD/SUD) resources across the community and encourage individuals to seek help through increasing the number of connections to Flagler Cares.

# Behavioral Health: Drug and Substance Use

**Goal 2:** Increase the proportion of children and adolescents with behavioral problems who receive developmentally appropriate evidence-based treatment. *(Healthy People 2030)*

**Objective 2.1:** By December 31, 2025, increase the percentage of Flagler County Schools faculty/staff trained in Youth Mental Health First Aid from 23% (2022) to 80%.

AdventHealth Palm Coast partnership includes \$10,000 annual financial investment to Flagler Schools for mental health fund. Funding to help provide Youth Mental Health First Aid training for school-based faculty and staff. Youth Mental Health First Aid is designed to teach parents, family members, caregivers, teachers, school staff, peers, neighbors, health and human service workers and other caring citizens how to help an adolescent (age 12-18) who is experiencing a mental health or addictions challenge or is in crisis. Youth Mental Health First Aid is primarily designed for adults who regularly interact with young people. The course introduces common mental health challenges for youth, reviews typical adolescent development and teaches a 5-step action plan for how to help young people in both crisis and non-crisis situations. Topics covered include anxiety, depression, substance use disorder in which psychosis may occur, disruptive behavior disorders (including AD/HD) and eating disorders.

**Objective 2.2:** By December 31, 2025, increase the number of student referrals being made through the LINC (Linking Individuals to Networks of Care) system to 800 total referrals from a baseline of 502. Flagler County School students are referred through LINC Flagler Volusia to behavioral health services. LINC is a multi-agency data system that enables trusted providers to send referrals to a network of other service providers on behalf of individuals seeking behavioral health assistance. Organization staff can securely communicate with other care team providers through the system to collaborate on services and supports.

# Behavioral Health: Drug and Substance Use

**Goal 3:** Partner with SMA Healthcare Peer Specialist to benefit people who are encountered in the Emergency Department to go into treatment for behavioral health.

**Objective 3.1:** Partner with SMA Healthcare Peer Specialist to increase the number of people who are encountered in the emergency department with substance use disorder who are connected to appropriate treatment services. In addition, connect the patient (and peer) with Mission and Ministry if additional support is needed. By December 31, 2025 Mission and Ministry will connect with 12 patients and peer specialists. *(Faith Community Strategy)*

**Target Population:** Adult Hospital patients suffering from substance use disorder in Flagler and Volusia Counties.

# Early Childhood Education

The assessment showed that the percentage of youth ready for kindergarten at entry has increased in Flagler County, although it is still lower than that of the state. According to public data, only 41.6% of toddlers in the community are enrolled in preschool, which helps prepare youth for kindergarten and beyond. The Hospital prioritized early childhood education because of the foundation it provides for better health and long-term outcomes for all residents.

**Goal 1:** Increase the proportion of children who participate in high-quality early childhood education programs. *(Healthy People 2030)*

**Objective 1.1:** By December 31, 2025, partner with Early Learning Coalition of Flagler & Volusia Counties (ELCFV) to host three educational events with invited experts who will discuss the importance of early learning. These events will be used as an opportunity for all families in attendance to enroll their children in services offered by ELCFV, including Florida’s Voluntary Prekindergarten (VPK) program.

Research shows that when learning is part of a game, fun activity, or everyday routine, information sticks longer. Through Florida’s Voluntary Prekindergarten (VPK) program, children can learn all developmental domains through play. The eight domains include: Physical Health, Approaches to Learning, Social and Emotional Development, Language and Communication, Emergent Literacy, Mathematical and Scientific Thinking, Social Studies and The Arts, and Motor Development. Families will have opportunity to enroll in the 3Ts. The 3Ts program is comprised of free resources designed to help parents understand how important their role is in their child’s brain development.

**Objective 1.2:** By December 31, 2025, partner with Early Learning Coalition of Flagler & Volusia Counties to provide approximately 3,600 summer take home bags for VPK students to prevent summer reading loss in preparation for kindergarten.

**Objective 2.2:** By December 31, 2025, partner with Early Learning Coalition of Flagler & Volusia Counties to offer three clinical provider information sessions dedicated to the importance of developmental screenings both through School Readiness and Help Me Grow which provide tools to move children forward in their skills outside of the classroom.

# Early Childhood Education

**Goal 3:** Increase the proportion of children with a developmental delay who receive special services to meet their developmental needs by 48 months of age. (*Healthy People 2030*)

**Objective 3.1:** Partner with Easterseals Northeast Central Florida offering behavioral intervention services. By December 31, 2025, provide 5 information sessions on The P.L.A.Y. Project to expand the scope and reach of services. The P.L.A.Y. Project is an Autism training and early intervention program, and Easterseals offers P.L.A.Y. therapy at their Autism Center of Excellence (A.C.E.). Partner donations allow them to serve more children ages 18 months to 6 years with gaining language and social skills.

Data in the assessment highlighted how complicated the health care system can be to understand and navigate, even for those who work within the industry. Many stakeholders discussed how disconnected different parts of the health care system are, leading to a lack of care coordination between different providers and a low awareness in the community of what services and resources are available. Word-of-mouth tends to be the best method to share information, especially in priority populations. The Hospital hopes to improve the health of the community, by increasing community engagement and awareness of the resources and services available that improve health and connecting residents to them.

**Goal 1:** Increase access to income and health insurance coverage for vulnerable individuals.

**Objective 1.1:** Provide access to a SOAR Processor (SSI/SSDI Outreach, Access, and Recovery) through partnership with Flagler Cares SOAR to assist 180 eligible Community Care patients to apply for and obtain SSI/SSDI benefits (to including income and Medicaid/Medicare) by December 31, 2025.

**Goal 2:** Increase social and community support to improve health and social outcomes for underserved populations. (*Healthy People 2030*)

**Objective 2.1:** Increase the number of area non-profit organizations trained on the Whole Health Hub and thus added to the Whole Health Hub's Trusted Network. The Whole Health Hub is a free website that allows anyone to search and connect to a wide variety of social services based on their location. By December 31, 2025, we will increase the number of claimed non-profit organizations to 30 from a baseline of 18. (*DEI – AHDB, AHD, AHFM, AHNSB, AHPC*)

**Objective 2.2:** Host presentations recommending the Whole Health Hub (WHH) for AdventHealth team members to become familiar with. Presentations will encourage team members to register for trainings through the AdventHealth Learning Network and refer patients to Whole Health Hub. By December 31, 2025, host 11 presentations from a baseline of 2 to promote and increase the use of Whole Health Hub among team members.

**Objective 2.3:** Invite faith communities to join the Whole Health Hub and promote use of the platform to help individuals find free and low-cost services/resource in the community. By December 21, 2025, we will increase the number of claimed faith-based non-profit organizations to 12 from a baseline of 6. (*Faith Community Strategy*)

# I Priorities Not Addressed

AdventHealth Palm Coast also identified the following priorities during the CHNA process. In reviewing the CHNA data, available resources, and ability to impact the specific identified health need, the Hospital determined these priorities will not be addressed.

## Mental Health

There is a growing need in Volusia County to increase the available resources addressing mental health needs. The assessment found the percentage of adults reporting poor mental health is slowly increasing statewide, as well as in Volusia County. However, Volusia County rates are notably higher than statewide rates (17.2% and 13.8%, respectively). Volusia County also lags behind the statewide average for both mental health providers and adult psychiatric beds.

The mental health needs of the community are significant, but the HHNAC did not perceive the ability to impact the issue with existing Hospital resources at this time.

## Housing and Income

The need for safe and affordable housing and increased wages in the community is significant. More than one-third of homeowners (about 34%) and over half of renters (about 55%) are paying over 30% of their income towards housing. The median price of homes also increased 18.8% from November 2020 to November 2021. The assessment also found that Black residents are twice as likely to be living below the federal poverty level as their White counterparts, and the poverty rates of Other Race and Hispanic residents are also notably higher than White and Non-Hispanic residents.

The HHNAC did not perceive the ability to have a measurable impact on these issues within the three years allotted for the Community Health Plan with the current resources available to the Hospital at this time.
